### Financial and Measurement Highlights

- Biggest challenge is sustainable funding

#### Real Estate

- Construction at new Henderson St building proceeding well On budget and on schedule.
- Expected first day of service at new building is Tuesday, April 2, 2014
- 551 Whiting Street building is in escrow. The buyer is proceeding with inspections. If acceptable the buyer will increase deposit to total of \$20,000 (non-refundable) on Feb 13, 2014.

MOTION: Resolution for Approval: Board President Bob Thurman and Executive Director Sue Van Son are authorized to sell 551 Whiting Street on behalf of Interfaith Food Ministry of Nevada County for the price of \$200,000. Note: Authorization to sell 551 Whiting Street was approved unanimously by the IFM Board on November 26, 2013. A quorum was present with thirteen Board members voting Yes and two absent. Approved unanimously

#### Grants

 Kathy Mollet submitted a grant request to Morgan Stanley which was approved for \$2000. Funds will likely be disbursed by March or May of this year.
