### **Item: Fund Raising**

## Item: Real Estate - Partnering Against Hunger

- Status of USDA loan: The loan has been 'obligated'. Prior to funds being released USDA Letter of Conditions must be met. Expected escrow close mid-July.
- Additional costs are arising to meet code and repair requirements for the building. Total estimated cost for building and improvements has increased from \$750,000 to \$800,000. May need additional funding from the IFM facility fund.

**Action**: Motion: Board will allow IFM to spend up to \$50,000 more above the \$750,000 targeted for building construction expenses – Up to \$800,000. Passed unanimously.
