Saturday Distribution

There have been 6 distribution Saturdays to date with a total of 114 family visits

Adults - 190, children - 121, seniors - 61

New families - 22

- IFM and United way met and decided to continue the second Saturday distribution for another 6 months with slight modifications
- An increased effort will be made to try to reach families who don't think they qualify

Holiday Meal Program (Sue) and Communication Plan (Kate)

- Holiday meals will be given to clients on their regular distribution day during the two weeks prior to Thanksgiving and Christmas
- The Food Bank of Nevada County is providing some of the food
- The Salvation Army will buy crescent rolls and butter for both Thanksgiving and Christmas
- Placer Food Bank is giving IFM the chickens for the singles
- For the Christmas distribution Ladies' Relief Society will also be involved
- Sponsor a Family for the holidays
 - A \$20 donation will help Interfaith provide the food for a family of four
 - A \$40 donation will help provide the food for Thanksgiving and Christmas
 - Gift cards can be purchased so that you can give the gift of sponsoring a family for the holidays
 - Board members were given an envelop with the gift cards and asked to share this project with their church members
- Store Ambassadors are needed to greet shoppers and encourage participation during the local grocery store holiday food drive
 - The hours are flexible and it is a great family or youth group project
