Thanksgiving Distribution

- 909 families received food for their Thanksgiving meals
- May make some changes for distribution next year
- · Christmas distribution will probably start earlier in the morning

Working Poor Outreach and United Way Update

- IFM Executive Committee met with representatives from United Way
- Ongoing discussion about the possibility of Saturday distribution once a month
- Weekday distribution difficult for the working poor
- Could possibly start in April pending staffing, funding, and the ability to get more food
- United Way may help fill gaps in volunteers and/or financing
- IFM would need volunteers, especially supervisors, who would be willing to work one Saturday a month

Project Heart Facility Use Agreement Update

- Agreement is in order
- Project Heart groups will meet in Suite A on Monday and Thursday evenings starting in January

CalFresh Program Update

- Nevada County pays IFM to have trained volunteers talk with clients about CalFresh
- We have signed up 6 people so far

KVMR Hunger Forum

- Program went very well
- Live and podcast
- Yuba Net was there online news service. It was IFM's first exposure to them

Insurance Requirements For Onsite Contractors

• IFM will now require that any contractors we use have insurance and workman's comp.

Benches

- Rotary of Grass Valley South donated an outdoor bench for us
- A plaque will be made
- The bench we already have is from Grocery Outlet
- Benches are about \$430 a piece excluding tax and shipping
- Will check with more service clubs to see if they are interested in donating a bench

Food

- Two bags of staples are now being given to families of 6 or more
- More tuna is being given to larger families
- Broccoli was purchased for the Thanksgiving meals
- Very preliminary discussions about creating a prep kitchen in suite A for cooking classes
