FINANCE

Sponsor a Family Fundraising Update

- We are ahead of where we were at this time last year.
- Board encouraged to keep promoting it

Safeway Feed the Need and Store Ambassadors

- Kate thanked the Ghidotti High School students and the Boy Scouts from the Mormon Church who acted as enthusiastic ambassadors.
- Many, many times the number of bags are purchased when we have store ambassadors outside of the Safeways
- There is still a need for more volunteers
- Hours are flexible

Run for Hunger Venue

- We are awaiting the final OK to hold the Run for Hunger at the Nevada County Airport.
- This would be at no cost to IFM
- It will be held the last weekend in September or the first weekend in October

OPS UPDATE

Saturday Distribution

- Hours were shortened to 10:00-12:00 as of last month. This worked well.
- 38 families received food
- There were four new families
- Thanksgiving distribution was also done on that Saturday for those families

Thanksgiving Distribution

- This was done over 5 days
- Clients received their holiday meal along with their regular distribution
- 1183 families received food for their Thanksgiving meal including a whole chicken for one and a turkey for families of two or more

Upcoming Christmas Distribution

- Will take place on the 6 distribution days prior to Christmas
- Clients will receive ham (some turkeys and chickens), applesauce, scalloped potatoes, and mustard.
- A meeting took place following the board meeting to try to work out a few problems that occurred with the Thanksgiving distribution and to make the Christmas distribution more efficient

Emily (Monitor) update

- She is progressing with this new role
- Jeff Hebert spent a day working with her so that he knows the role if he needs to substitute for her

Placer truck

- We have volunteers who have been driving to Beale Air Force Base to buy the meat we give to clients at the holidays. The truck they use is not covered and does not have an automatic lift. This causes problems if it rains and is dangerous for those trying to unload the truck. If we don't have a truck by the holidays next year, we will have to purchase food from an agency that delivers and that may be more expensive.
- Placer Food Bank is willing search for a grant to buy a truck that will have a lift gate. Placer will insure it and maintain it, but it will be housed at IFM. We'd probably be responsible for gas. We'd need a driver who is trained with them.

USDA Inspection

- · Their inspection involved meat and eggs
- We are totally in compliance
- We are not allowed to distribute butchered beef, chicken, lamb and pork that is donated by local farms as it does not have the USDA stamp

Volunteers

- We continue to need drivers
- We need Thursday packers

Food

- We will buy broccoli throughout the winter again this year
- Antonio, the new owner of Riverhill Farms, wants to continue providing food to IFM

Solar panel system

- DC Solar provided an additional 12 panels and they are up and running
- We have 92 panels total and they are guaranteed for 25 years

Employee Handbook

Food Bank of Nevada County relationship - Bob and Sue

- We are working on increased collaboration between IFM and Food Bank
- Both organizations want to feed the hungry but have different approaches
- A question was asked about Placer Food Bank, and it was explained that they are a hub for Feeding America in Placer, El Dorado and Nevada Counties. They do not give food directly to clients, but they distribute food to 62 different agencies.
