# TREASURER UPDATE

- John explained that best practice says there should be two assistant treasurers one to handle all deposits of donations to IFM and the other to handle payments to vendors, etc.
   Jeff Hebert nominated Rita Kahil to be the assistant treasurer to handle deposits. There were no other nominations. Cherie Eckholt moved to approve Rita Kahil as a second assistant treasurer. Debi Johnson seconded the motion and it was unanimously approved.
- Fidelity bond update
   This bond is to protect IFM against fraud
   The position of development director is being added to this bond
- Mileage reimbursement policy
   There was a good discussion regarding reimbursing IFM drivers who request it while staying within IRS
   guidelines. The board is in favor of doing something as we don't want to lose drivers. Bob Thurman suggested
   that we wait and see if Connecting Point will reimburse drivers who come through them as RSVP did in the past.
   Then it will be considered in executive committee with a recommendation coming to the board.

## **OPERATIONS UPDATE**

- Development Director search update Kate will be resigning in the next 6-8 months The search has started for someone to fill her job – mainly fundraising, marketing, and public relations
- Food Access Saturday
   We all need to really get the word out so that those who are working or going to school full time can take advantage of our 2<sup>nd</sup> Saturday distribution
- Client Area update for would-be clients without IDs
   White slip will be used
   Receptionists will route them directly to Phil or Kate who will explain to them how to go about getting their ID
   They will be given some food
- Grant tracking, handoff, ownership process A more systematic, month-to-month tracking system will be put in place, hopefully by January
- Suite A floor project
   Suite A flooring will be redone to match the rest of IFM on September 29<sup>th</sup> and 30<sup>th</sup>
   From 2:00-5:00 on Friday, helpers are needed to finish emptying Suite A and from 2:00-5:00 on Sunday, workers are needed to put things back into Suite A
- Placer Food Bank truck
  - The truck is here and in use
  - 18 foot refrigerated truck
  - IFM covers the drivers and the gas
  - Team of 4 trained drivers (5 counting Phil as back-up driver) pick up food at Placer Food Bank on Tuesday and Thursday mornings
  - Having this truck will enable IFM to do more local pick-ups that require a refrigerated truck
- Grass Valley Chamber of Commerce It was recommended that IFM join the GV Chamber of Commerce The cost is \$150 a year as a non-profit
- Food Committee Update
  - The next cooking classes will be Nov. 6<sup>th</sup> and 8<sup>th</sup> from 11:00-12:00
  - They will be about making soups in crockpots
  - Clients attending will receive a crockpot appropriate to their family size and the necessary ingredients to make the demonstrated soup
