City Homeless Meeting Update

Rick Kahil and Kate Laferriere

- Universalist Unitarian Church hosted a presentation on homelessness in Nevada County
- Heidi Hall, accompanied by Brendon Phillips, presented
- Official count in Nevada County is 371, but the county doubles that number because so many don't come in for the count
- Homeless are not being bussed into Grass Valley
 - 25% have lived here all their lives
 - Another 38% have lived here more that 15 years
 - A total of 79% have been here more that 2 years
 - 85% have family in Nevada County
- Nevada County recognizes that there is a housing & wage crisis
 - Looking for appropriate housing possibilities
 - Priority is housing first while looking to put together a whole wrap around program
- · Other communities are grappling with the same issues

OPS UPDATE

Monitor

- Emily was introduced as our new security monitor
- She will work in the client area during our distribution hours on Monday, Wednesday, and Friday for a salary and benefits of \$7,000 a year
- Jeff Hebert will serve as her backup in a volunteer capacity

Saturday distribution

- Will continue on the 2nd Saturday of the month for another 6 months
- Hours will be 10:00-12:00
- United Way will continue to provide much of the funding and a core team for distribution
- IFM will provide the supervisors and those who work in the client area
- Will reevaluate in April at the 1 year mark

GVPD

 Sue talked with the Grass Valley Police Department and they report less trash, less discarded food and less cooking over an open fire since IFM modified some distribution policies

CalFresh contract

- We've renewed our contract.
- Connie Mattis will continue to sign up clients who are interested
- Emily will be in the client area and will be able to canvas to see who might be able to use their services
- We will be able to bill for her services

Cooking classes

- Recent cooking classes have been held at the Briar Patch Cooking School
- Many were signed up and called to remind them of the class, but not many show up
- Nancy Koring reported that we had a total of 10 clients for 2 cooking classes
- Those who attended loved it

Food and Holiday meal program

- We will continue to give out the holiday meals on regular distribution days the 2 weeks prior to the holiday
- The Food Bank is hoping to provide us with small turkeys for families of 1 or 2
- Some people will coming in with vouchers from Food Bank, Ladies' Relief Society, and Salvation Army
