MOTION TO APPROVE AUGUST 2016 BOARD MEETING MINUTES - APPROVED UNANIMOUSLY

#### **Bob Thurman**

Tim Gizzi was introduced as the probable new board member for Calvary Bible Church.

Tim will meet with the board president and the executive director to discuss the role of board representative and church volunteer coordinator.

Deaconess Elizabeth Froh from Grace Lutheran Church explained "The Hangout". Grace Lutheran provides a place where students, mainly from Nevada Union, can come after school. There are also some students from Sierra College who work as volunteers. Up to 40 students a day take advantage of a place to be and the food that is made available to them. For some of these students it's their only meal of the day.

A discussion followed regarding IFM providing some food that we do not buy to Deaconess Froh one time a week to be used to feed the students who utilize "The Hangout". A motion was made, seconded, and approved to do so.

Fred Viola, a probation officer, explain Project H.E.A.R.T. Inc. (Holding Excellence Above Relapse Team). It has been in existence for 6 years and it was started "to provide a group of true friends who support a consistent atmosphere that is safe, moral, ethical, and legal" for those "caught in the cycle of life damaging issues such as family and relational discord, substance abuse and criminal activity." The group for women meets on Mondays at 6:00 pm and the group for men meets on Thursdays at 5:00pm. They have outgrown the space they are currently using for their meetings, and it was proposed that Suite A and the patio area at IFM could be used for these meetings. A discussion followed. It was moved, seconded, and approved that IFM allows the use of Suite A and the patio area for Project H.E.A.R.T. for approximately 3 hours a week during non usage hours pending insurance checks and the signing of a facilities use agreement.
