Sue expressed thanks for the Thanksgiving distribution, which was very successful, although Fewer families than last year participated.

**Proposed Sale of Whiting Property** 

Proceeds will be used to pay down loan on new building. The listing price is \$219,000. Options to pay off the loan were presented by Kathy Mollet (future treasurer). Loan can be paid off through 3 options, five years, ten years, or 23 years. Her recommendation was 10 years, with a manageable impact to operations.

## 2014 Budget Assumptions

Budget assumptions (forecasts only) are to finish new building construction by March 1 of next year, with a move on April 1. Assumption not expected to sell Whiting building in 2014. Estimate is that clients served will increase about 27 percent and food costs are expected to increase 20 percent. (Return to weekly service expected July 1 pending funding and volunteer availability) Also, payment to part-time executive director expected to continue with same salary. Individual contributions and fund raisers same as last year. 15 percent increase in revenue needed.

ACTION: Vote to sell Whiting property. Passed unanimously.

ACTION: Sale agreement for Whiting to include options for seller financing. Passed unanimously. ACTION: For 2014, IFM will not seek to pay down the loan. (Except, any targeted Building Fund donations or sale of Whiting) and evaluate situation end of 2014.) Unanimous pass.
