- 37% increase registered families

Financial Summary by Treasurer Kathy Mollet

- Ordinary Income is a LOSS of \$44K
- Expenses managed very well less than 1% delta to revised plan
- 10 grant opportunities \$58.5 in budget, \$84K ask
- The Operating reserve guidelines were a review from a prior board meeting no vote

- Client demand forecasted up net 7%
- No weekly service at this time

- All other expenses expected to be down 5%

Operating Reserve Guidelines

Proposal to carry no less than 3 mos. And no more than 6 mos. operating cash to be measured forward each December 31st taking into consideration at least a 2 year trending window.
