DRAFT BYLAWS - Diane Chang

Handout was passed out outlining most needed foods. With diabetes on the rise healthy food options are being evaluated.

QUARTERLY FINANCIAL REVIEW – Kathy Mollet

Balance sheet healthy.

Ahead on total income mostly due to anonymous donation and matching campaign.

Food and food supplies are under budget due to great work by the Food Committee. Savings will be used to provide increased holiday meals as a result of the Food Bank not being able to do Holiday meals this year.

As agreed previously cash available beyond reserves, grant money, and fundraising will be used to support the solar panel project. The majority of the utility savings will go to purchasing food.
