Board Secretary confirmed a quorum.

Kate LaFerriere led us in prayer.

Bob introduced guests Curtis McMullen, representing Nevada County Children's Behavioral Health, Aurora Packard, Grass Valley's local YMCA Program Coordinator and John Brusher, possible candidate for IFM Treasurer Position.

Curtis McMullen explained their summer program and the need for healthy snacks. Motion was made by Nancy Koring that IFM assist in providing healthy snacks for this program, seconded by Marnie Ratkovsky and passed.

Aurora Packard talked about the YMCA summer program being held at Memorial Park for underserved children. This program also needs donations of healthy snacks. A motion was made by Tim Gizzi for IFM to support this program by providing healthy snacks, seconded by Jim Schroeder and passed.

At the May Board meeting, there was not a quorum present, so Bob explained and presented the following motions:

#### **FINANCIALS**

- There was a motion to remove Kathy Mollet as Treasurer and confirm current Board Officers (Bob Thurman Board President, Rick Kahil Board Vice-President, Mary-Ellen Tracy Board Secretary, Treasurer TBD), in order to update Chase Bank USDA reserve account. Authorized signers for the Chase account to be Phil Alonso, Executive Director and Bob Thurman, Board President. A motion was made by Marnie Ratkovsky, seconded by Joan Denzler and passed.
- 2017 key audit findings. There were no real issues. We are in compliance. All bills will be
  authorized by Phil Alonso going forward for payment. A motion was made by Jeff Hebert,
  seconded by Anne Lyon and passed.
- 2017 tax filing was on time including the registration for California Non-profit Status. A motion was made by Jeff Hebert, seconded by Marnie Ratkovsky and passed.
- Parking lot re-pavement project: Bob explained the scope of the project, which is estimated at 18,800 square feet. Because Beam Center is re-paving their portion of the parking lot, it would
