- MOTION: Oct. Minutes approved
- Vehicle Donation Update: Two vehicles will be donated to two families from Chris Collision, from six families nominated.
- Operations Update (Sue)
 - Thanksgiving give-away from Nevada County foodbank held on same day as distribution. Some clients could not do both as give-away held for only 2 hours.
 - IFM Christmas dates for distribution: Dec. 15, 17, 19, 22 (food bank clients on 20th)
 - o Hunger to Health: cooking classes to be scheduled

- Operations Update (cont)
 - Sue reported that her job is overwhelming. List of people needed for the following:
 - ➤ Public Relations Make sure each IFM event is publicized and appropriate thanks given (a PR page has been developed as a guide)
 - ➤ Oversee holiday distribution Christmas and Easter (Sue will work with new volunteer this Christmas)
 - Development director for fundraising
 - ➤ Media manager Monitor website to ensure all current info is updated and contact webmaster.
 - ➤ Website manager (I am adding this as it has become a need since the board meeting) finish building a new web page and manage updates and changes through out the year.
 - o Placer Foodbank. John Bradford now sits on Placer food bank board.
 - > Run for Compassion event on Dec. 13. IFM people welcome.
 - Gala Event. May 2 at IFM.
 - ➤ Board members asked to contact churches about borrowing dishes, chairs, pots, silverware. Contact Debbie Hoflin. Expect about 180 people.
 - ➤ Dessert Auction: Board members please give names of people to Sue who can make beautiful and delicious desserts to be auctioned off on May 2.
 - Safeway push for grocery bags is over. 300 bags bought at Brunswick. \$1,000 check donated.
 - o Food drives by youth at various schools successful.
 - Resource for clients: Second Harvest places gardens in homes. (located on Zion St. in cooking school). Group also provides heathy food cards in schools.
 - New thrift store: Abrakadabra opening soon. They are presently taking donations.
 Flyer distributed to board for churches.
 - o Sponsor a Family gift cards available from Sue.
 - o Food bank no longer does emergency distribution on Tues. and Thursday.

Executive Committee Update

- Discussed preview to annual meeting.
 - Focus on more interaction, fewer slides. Board encouraged to invite pastors.
 - ➤ Main elements will be 2014 summary and a look forward to 2015.

Executive Committee Update (cont)

- Preliminary assumptions for 2015:
 - Continued focus on providing healthy food and cooking classes.
 - Operations no new initiatives. Focus on continuous improvement and safety.
 - ➤ No planned return to weekly distribution. However more food/client given.
 - > Client demand forecast to increase 5%.
 - > Income expected to be flat.
 - Expenses expected to be flat except food costs expected to increase.
- o IFM Call to Action plans for next year Ways to increase donations:
 - ➤ 1st Campaign Matching Campaign March & April 2015
 - Seeking matchers willing to donate up to \$25k
 - Currently have \$10k in matching funds, need \$15k more
 - ➤ 2nd Campaign Lost Donors
 - o Encourage 'inactive' donor's to give again
 - > Possible 3rd campaign Year end appeal (if we need funds)
- Call to Action Other Opportunities
 - Grants- McDonalds and others
 - Fundraisers
 - Paulette's in Sept. brought \$7K
 - Gala Event in May 32K
 - Shredding Day 4K
 - Ideas for possible new fundraisers?
 - ➤ Planned Giving (Endowments, estate planning) John Tracy may support?
 - > Social Media need someone to manage, on back burner for now.
- o Reserve Guideline to be presented for approval at January Annual Meeting
 - Likely proposal: Amount of cash IFM should carry 3 to 6 mo. cash on hand. Now have about 4 ½ mo. of cash.
 - ➤ When/if we exceed high target of cash on hand we would use to pay down building loan.
