Mid-year financial review (Detail will be posted on IFM website under "About Us")

- Total registered families 24% increase from last year. Total of 3,096.
- Receipts up 19%.
- Building Fund up 36%.
- Food expenses down, primarily due to Placer County Food Bank providing free and lower cost food.
- Operations fund going down in Sept. perhaps focus on re-occuring donations. Ask people who have given to make it a regular habit.

Fact Sheet figures (Detail will be posted on IFM website under "About Us")

- 2/3 of clients are multiple users (3 or more times)
- Food donations up 20%
- Value of one bag of food \$22. Up 19%.
- Members advised that IFM can purchase \$2 of food for every \$1 donated.
